# Ways to support the work of the Foundation

Scotch College sincerely appreciates all gifts – large and small – but you might find the following helpful when considering your support.

Please note: All gifts over \$2.00 to the ‘Scotch College Building Fund’ or ‘Scotch College Library Fund’ or ‘The Scotch College Foundation Endowment Fund’ are fully tax deductible.

## Options

*The Building Fund* – support for capital work. It provides for the upkeep and maintenance of existing buildings, the redevelopment of old buildings and construction of new buildings according to the school needs.

*The Library Fund* – support for the libraries and library services of the school.

## Other

An endowment is a fund/funds in which the assets are preserved in the interests of future generations. It is therefore permanent and donations to it will help Scotch in perpetuity.

*The Scotch College Foundation Endowment Fund* – provides funding for a variety of scholarships which are open to any student who is an Australian citizen. These scholarships include academic, needs-based, boarding, music and other Arts or sporting activities.

*Endowment for Staff Salaries* – gives the flexibility to attract and retain appropriate teaching staff through salary incentives, and also stimulates the work of individual departments through academic chairs.

*Endowment for Prizes* – provides funds for annual prizes, special grants and awards made to students.

*Membership of the Foundation* – Life membership of the Scotch College Foundation will be granted to donors who pledge gifts of \$5,000 or more, whether or not a naming opportunity is associated with the gift. Levels of membership of the Foundation are:

- Trustee \$75,000 or more given over five years (\$15,000 per year)
- Senior Fellow \$25,000 or more given over five years (\$5,000 per year)
- Fellow \$10,000 or more given over five years (\$2,000 per year)
- Associate Fellow \$5,000 or more given over five years (\$1,000 per year)
- Membership of The Forbes Society is granted to each donor who makes a gift of \$250,000 or more
